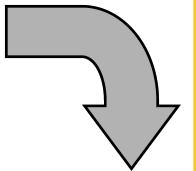


How Can Senior Legal Aid Help Solve These Problems?

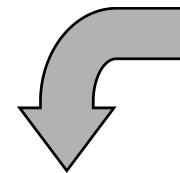
Any needy senior West Virginian age 60 or over can call our toll-free number

You never have to come in to our office, we can serve you from your home by telephone.



We will ask the senior a few questions (name, address, phone number, birth date, etc.) and schedule a time for an attorney to call the senior back that day.



When the attorney calls she will figure out what legal solutions we can try to solve the problem.
